Water(Aqua), Butylene Glycol, Hamamelis Virginiana (Witch Hazel) Water, Urea, Yeast Amino Acids, Trehalose, Inositol, Taurine, Betaine, Chondrus Crispus (Carageenan) Extract, Prunus Persica (Peach) Fruit Extract, Anthemis Nobilis Flower Extract, Sodium PCA, Lecithin, Tocopherol, Magnesium Ascorbyl Phosphate, Palmitoyl Hydroxypropyltrimonium Amylopectin/Glycerin Crosspolymer, Vitis Vinifera (Grape) Seed Extract, Cucumis Sativus (Cucumber) Fruit Extract, PEG-12 Dimethicone, PEG-40 Hydrogenated Castor Oil, Chlorphenesin, Methylisothiazolinone, Sodium Citrate, Disodium EDTA, Benzyl Salicylate, Geraniol, Linalool, Citronellol, Fragrance (Parfum), Orange 4 (CI 15510), Red 4 (CI 14700).
