## **SECTION 6 – ACCIDENTAL RELEASE MEASURES**

Personal precautions : Remove all sources of ignition. Ensure clean-up is conducted by trained

personnel only. Refer to protective measures listed in Section 7 and 8.

Environmental precautions : Do not allow contact with soil, surface or ground water.

Methods of cleaning up

: Eliminate all ignition sources if safe to do so. Stop leak if safe to do so. Contain spillage, and then collect with non-combustible absorbent material (e.g., sand earth, diatomaceous earth, vermiculite) and place in container for disposal according to local, state, and federal regulations (See Section 13).
