### 4. FIRST AID MEASURES

#### Description of necessary measures

<b>Inhalation:</b>	First aid measures not required.
<b>Skin contact:</b>	First aid measures not required. Cosmetic product and therefore not necessary.
<b>Eye contact:</b>	Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation develops.

#### Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation.
